**Pattern (Poomsae):**

**a) Individual Junior Poomsae (14 - 18 years old):**

Individual Poomsae are divided into male and female divisions (Individual Junior Male Poomsae and Individual Junior Female Poomsae): one (01) contestant per division from each team.

**b) Individual Senior Poomsae (19 years old and over):**

Individual Poomsae are divided into male and female divisions (Individual Senior Male Poomsae and Individual Senior Female Poomsae): one (01) contestant per division from each team.

**c) Pair Poomsae:**

Each team shall send a pair of male and female contestants with no age limit.

**d) Team Poomsae:**

Team Poomsae are divided into male and female divisions. Each team consists of 3 contestants with no age limit.

**\*\*\* Four poomsae shall be performed in two rounds as follows:**

- Preliminaries (over eight participants): contestants of individual, pair and team poomsae events shall perform two (02) of the 1<sup>st</sup> four following compulsory poomsae, and eight contestants shall be selected based on their points

\* Junior: Taegeuk 4, 5, 6, 7 Jang

\* Senior: Taegeuk 6, 7, 8 Jang and Koryo

- Finals: contestants of individual, pair and team poomsae events are required to perform two (02) of the 2<sup>nd</sup> four following compulsory poomae.

\* Junior: Taegeuk 8 Jang, Koryo, Keumgang, Taebak

\* Senior: Keumgang, Taebak, Pyoungwon, Shipjin

**10. AWARD PRESENTATION:**

- Team winners are decided according to the number of gold medals that each team won, in case the number of gold medals are the same, then it depends on the number of silver medal and in case the number of silver medal are the same, then it depends on the number of bronze medal.
- The top five participating teams will receive trophies. Some of Good Fighting Spirit Prize and Active Participation Prize will be awarded to the pertinent teams

**11. TERMS AND CONDITIONS OF PARTICIPATION:**

- a) Roundtrip airfares and accommodation charges of room and board shall be borne by the participating national associations.

- b) Members of team (officials & contestants) and others (supporters) must stay at the hotel arranged by the Organizing Committee.
- c) Entry fee: US\$ 20 per participant for poomsae competition event and Junior free sparring individual competition ; US\$ 200 per team (male and female respectively) for senior free sparring individual competition.
- d) Room including breakfast and inland transportation for each participant.
  - Official members of team: US\$ 40/a day/1 person
  - Others: US\$ 50/a day/1 person
- e) All fees must be paid IN CASH in US dollars only at the registration desk before checking in at the Hotel.
- f) Before June 3<sup>rd</sup> and after June 8<sup>th</sup>, 2009 please kindly contact the organizing committee for hotel accommodation and meals.
- g) The Organizing Committee shall not be responsible for any matter occurred during the championship if you do not stay at the host hotel.

## **12. INTERNATIONAL REFEREES:**

- a) The World Taekwondo Federation (WTF) upon the recommendation of the ASEAN Taekwondo Federation (ATF) will appoint required number of International Referees (each participating country recommends 02 kyorugy I.Rs. and 01 poomsae I.R.).
- b) Roundtrip airfares shall be borne by each national association of those referees, while five (05) nights' charges of room and board (check-in on morning June 3<sup>rd</sup> and check-out on morning June 8<sup>th</sup>, 2009) shall be covered by the Organizing Committee.
- c) The Organizing Committee will provide each participating referee with an allowance of US\$ 70 per day for three (03) days of competition.

## **13. WTF-RECOGNIZED TAEKWONDO UNIFORM (DOBOK) AND PROTECTIVE EQUIPMENT:**

- a) The participating contestants shall wear the WTF recognized Taekwondo uniform (Dobok) and the WTF recognized protective equipment of head protector, trunk protector, shin and forearm guards, groin guard, hand protector, foot protector and mouthpiece.
- b) The Organizing Committee shall provide the head gear and trunk protector for the participating contestants, while groin guard, shin & forearm guards, hand protector, foot protector and mouthpiece shall be brought by the participating contestants for personal use.
- c) Wearing of the WTF-recognized Taekwondo uniform (Dobok) and protective equipment will be checked at the inspection desk before entering the contest area and any contestant wearing unrecognized Dobok or protective equipment will not be permitted to compete.
- d) The list of companies for the WTF recognized Dobok and protective equipment is enclosed herein for purchase in advance.

## **14. WEIGH-IN:** weigh-in will be conducted one day before the pertinent matches.

## **15. INDEMNITIES:**

- a) It shall be the responsibility of the respective national associations to ensure that their participants have validly completed the official participation forms and have them signed indemnifying the organizers, its officials and other contestants from any claims of injuries, losses, fatal or otherwise arising in the course of participation in this championship or any activities thereto.

- b) It shall be the responsibility of the respective national associations to ensure that all officials and participants are covered with effective insurance coverage.
- c) Participants without proper participation entry forms and effective insurance coverage will not be allowed to compete.
- d) The Organizing Committee will ensure at its own expenses for the competitors against any injury and what so ever, in the course of competitions.

**16. HEAD OF TEAM MEETING & DRAWING OF LOTS:**

- a) The head of team meeting and drawing of lots shall be conducted one day prior to the competition in the presence of officials and the representatives of the participating nations and the draw shall be done from fin weight to heavy weight category in the English alphabetical order of the official names of the participating nations.
- b) An official shall be designated to draw lots on behalf of the officials of participating nations not present at the draw.
- c) The order of the draw may be changed according to the decision during the head of team meeting.

**17. NATIONAL FLAG AND ANTHEM:**

It is the responsibility of each participating national team to bring the following items for use in the opening & closing ceremonies and awarding ceremony.

Two (02) national flags, size 90cm x 130cm (only IOC recognized flags will be permitted) and a cassette tape/CD of your national anthem.

**18. FIRST ENTRY FORM AND CLOSING DATE FOR ENTRIES:**

The deadline for the official entry forms to reach the Organizing Committee is on the 25<sup>th</sup> of May 2009 and entries received after the deadline will not be entertained. Strict compliance with this ruling is hereby requested.

**19. VISA ENTRY:**

The Organizing Committee will help the participating teams for entry visas if requested before May 15<sup>th</sup>, 2009. We are not responsible for the requests after this date.
